We'll be teaching leaders from five different churches and need to print about 75 copies of the Romans course in Nepali, so please pray for the financial needs."

Krishna also shared some practical challenges and praises. Their laptops, essential for translation and course preparation, had stopped working, but God graciously provided a fix. They are now praying for office space in Kathmandu to serve as a ministry hub, which would help their team coordinate the growing work across Nepal.

Thirdly, he shared an encouraging development concerning a youth camp in Dhangadhi, where about 70 young people gathered for three days of teaching through *Romans 1-8* and other foundational truths.
